The Issue

The National Guard and Reserve Equipment Account (NGREA) is vital to ensuring the readiness and lethality of National Guard equipment and weapons systems through innovation and servicemember-driven requirements.

Background

NGREA is Congressionally-added funding for the National Guard and Reserve intended to bridge equipment capability gaps between the Active and Reserve Components. The account directly supports growth or evolution in operational warfighting capability, as well as unfunded requirements and equipment shortfalls.

National Guard NGREA funds are also often utilized to outfit platforms, procured via Programs of Record, with equipment intended for domestic operations missions. This includes sensors and tracking equipment for vehicles, as well as firefighting and rescue systems for National Guard aircraft.

Army National Guard NGREA funding has been directed to purchase equipment bridging equipment; chemical, biological, radiological, and nuclear (CBRN) detection and communication kits; improved test equipment for legacy systems; rescue hoists; fire suppression water buckets; and mobile marksmanship training simulators.

Additionally, Air National Guard NGREA funding has been directed to purchase F-16 missile warning systems; F-15 infrared countermeasures; A-10/F-16/C-130H digital radar warning receivers; and tactical data link programs for HC-130J/KC-135/C-17/C-130J aircraft.

Recommendation

- Continue appropriating funding for NGREA within defense appropriations legislation, including a robust percentage for the Army National Guard and Air National Guard
