This is projected to increase given the growing availability of illicit fentanyl. Last year alone, more than fifty million fentanyl-laced, fake prescription pills were seized². This crisis must end and to do so will require all sectors to play a role.

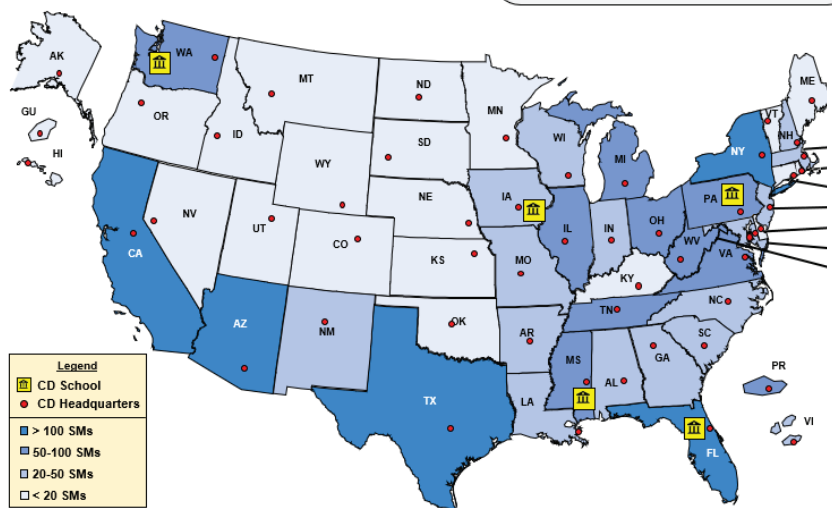
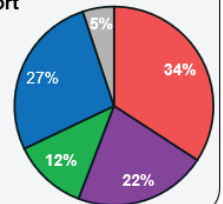

The National Guard Counterdrug Program is supported by ~1,600 servicemembers (SM) across 54 states and territories. In support of local law enforcement agencies, the CPD reduces the level of illegal drugs, illicit arms, and human trafficking in our communities.

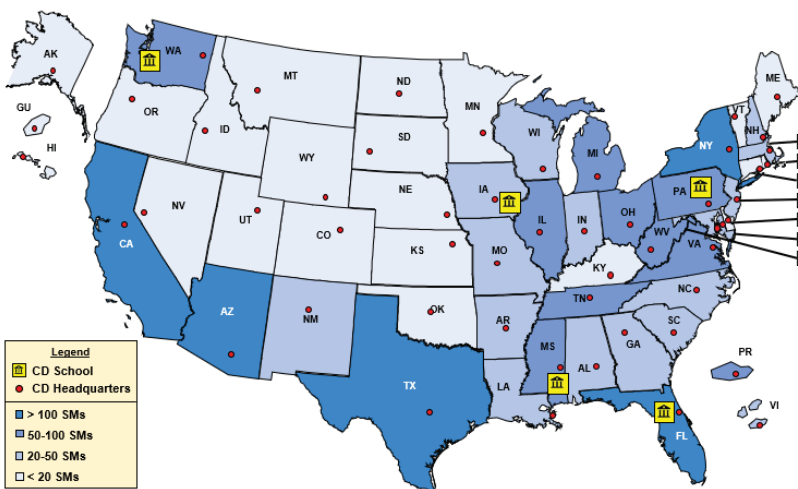
