The National Guard Counterdrug Program

Fiscal Year 2026 Fact Sheet

The opioid epidemic is wreaking havoc across the United States. Over 100,000 Americans die from overdose and cost the United States nearly \$1.5 trillion. This is projected to increase given the growing availability of illicit fentanyl. Last year alone, more than fifty million fentanyl-laced, fake prescription pills were seized. This crisis must end and to do so will require all sectors to play a role.

Since 1989, the National Guard has been combating the crisis in every state, territory, and zip code through the National Guard Counterdrug Program (CDP). This program provides trained professionals from the National Guard to work alongside local law enforcement and help get drugs off the street. In 2024, the program seized the following:

- \$579M in illicit U.S. Currency
- 53,480 kg of Fentanyl
- 42,442 kg of Cocaine
- 101,328 kg of Methamphetamines
- 1,298 kg of Heroin
- 89,286 kg of Synthetic Opioids

The National Guard is a true force multiplier. Each CDP analyst supports 10-15 agents already on the ground. Additionally, there are five CDP regional schools which train 68,000 active law enforcement officers per year on region-specific threats and proven techniques from the field.

Recommendation

The National Guard Association of the United States (NGAUS) urges Congress to provide \$460 million in funding to support the full 4,000 guardsmen IAW 32 USC 112, with an additional \$30M for the schools, IAW public law 109-469.

Despite proven success and the growing fentanyl crisis, CDP funding has remained stagnant since the early 1990s, at roughly \$200M annually. Stagnant funding has resulted in the loss of over 100 full-time personnel annually since 2018. Between much-needed salary increases and inflation, the CDP was continually asked to do more with less. In FY24 the CDP received \$305M. We request the Senate and House continue to provide incremental increased funding to support the full 4,000 guardsmen IAW 32 USC 112, with an additional \$30M for the schools, IAW public law 109-469.
