FY26 Defense Appropriations Memorandum | 13 June 2025

BLUF: On June 12, 2025, the House Appropriations Committee advanced **\$831.5B** for the Department of Defense (DoD) for Fiscal Year (FY) 2026 with a 36-27 vote. **Next Step:** The bill will be sent to the full House for consideration.

Funding levels and provisions cited below are proposed by the Chairman of the House Appropriations Committee and are subject to change.

Army National Guard

- \$11.3B for ARNG Personnel
- \$8.2B for ARNG Operation and Maintenance
- \$30M for Degraded Visual Environment Pilotage System (DVEPS)
- \$240M for MQ-1C Gray Eagle 25M aircraft, including:
 - \$5M for Gray Eagle Mods
- \$360M for AH-64 Apache Block IIIA aircraft, including:
 - \$100.5M for AH-64 Mods
- \$910M for 24 UH-60M Blackhawk Helicopters
- \$38.7M for Utility Helicopter Mods
- \$680.2M for 10 CH-47 Helicopters, including:
 - \$17.7M for CH-47 Mods

- \$100M for High Mobility Multipurpose Wheeled Vehicles (HMMWV) modernization for the ARNG
- \$345M for Joint Light Tactical Vehicles (JLTV)

Additional Provisions

Section 8043: Prohibits the use of funds to reduce authorized positions for military technicians (dual status) of the Army National Guard, Air National Guard, Army Reserve, and Air Force Reserve unless such reductions are a direct result of a reduction in military force structure.

Section 8152: Prohibits funds to divest F–15 aircraft.
