**BLUF:** On June 26, 2025, President Trump released the completed Department of Defense (DoD) budget for Fiscal Year (FY) 2026.

**Summary funding:** The President's budget requests \$1.01T in spending for the DoD, a 13% increase from FY25 enacted levels.
