The annual NGAUS Conference in Denver will serve as the platform meeting for the election of our new CAP representatives. Each candidate will be afforded the opportunity to address the attending corporate members at the ***OPEN CAP Meeting on Saturday, 31 August 2019, 0845 - 1000, Colorado Convention Center, Room 607.*** Ballots for the election will be available at this session, as well as from the NGAUS booth in the exhibit hall during the conference.

SPACE & THE NATIONAL GUARD



If there is a Space Force, should there be a Space National Guard? In a recent speech to the Air Force Associations, Lt. Gen. Scott Rice indicated that the Guard was engaged in the internal DoD planning for a future Space Force. Preparations for the establishment of the new service draw parallels to the development of the U.S. Air Force and its associated Air National Guard. Much like the Air Guard, an equivalent Space Guard Force would offer scalability of operations, supplemental resources and a bridge to civilian counterparts that would enhance the capabilities to the active duty force.

There are many reasons why there should be a National Guard component to a newly established and independent Space Force. One advantage is the cross-pollination with the growing civilian space environment. Many of the members of the Space Guard will likely have civilian jobs in the Space field. These citizen soldiers could serve as integrators between military and the civilian counterparts. Force management is another advantage. The Guard also serves as a great tool to retain talent as a part time force and helps with surge requirements. This last point also offers opportunities for cost savings. The Congressional Budget Office on June 26 set its cost estimate for standing up a Space Corps within the Air Force to \$3.6 billion. This includes \$2.3 billion on recurring personnel costs spread over five years and a projected one-time construction and renovation cost could range between \$1.1 billion and \$3 billion. Utilizing existing Guard assets for a proportion of these investment could result in savings across facilities and personnel.

The Guard contribution to Air Force Space Command already includes over 900 personnel within eight squadrons. Potential Guard mission could expand current mission such as missile warning, space situational awareness, satellite communications, and space electronic warfare. The Guard could also support emerging mission sets such as orbital warfare or the emerging training pipeline for Space Force operators. Guardsmen could provide critical knowledge management and continuity in each of these missions.

Factors such as the Guard component's size, command structure, and alignment with the active duty component will be instrumental in determining the actual Guard involvement in the emerging Space Force. Challenges to the integration of the Guard in the Space Force range from doctrinal to execution. On the doctrinal side, proper alignment would be essential to success. Placing the Space component under the National Guard Bureau would address key issues of force development and support. On the execution side, flexibility is required especially in effectively embedding part-time Guardsmen in missions that require constancy of action. However, such challenges are not insurmountable and are effectively negotiated by the Air and Army components.

So, should there be a National Guard component of the Space Force? Air and Army components of the Guard have proven very useful, providing alternative for citizens to serve that add additional and diverse capabilities to the regular forces. The Guard would be a tremendous asset in the development of the new service and in forging connections between military and commercial applications in a time when both are growing rapidly in the space arena. A Space Guard Force could be a source for innovative modernization, similar to the way the Air Guard component complements USAF today.

EANGUS CONFERENCE RECAP

The EANGUS National Conference convened in Des Moines, IA on 4 August. The leadership of the IA National Guard, the enlisted association of Iowa and the City of Des Moines did an outstanding job hosting the attendees from the 54 States, Territories and the District of Columbia. Over 900 people attended the conference including 140 Soldiers and Airmen below the rank of E6 who participated in Professional Development Courses. All attending received informative speeches and briefs from representatives of NGB, NGAUS, AGAUS and DoD .

The delegates attending conducted the important business of the national association by approving resolutions and legislative priorities to address the concerns, issues and programs effecting Soldiers, Airmen, retirees and families.

In conjunction with the conference, CSM Sampa, 12th CSM of the Army National Guard, hosted a State and Division CSM conference at Camp Dodge. The senior enlisted leaders of the States met with the Soldiers and Airmen during the professional development program.

Over 70 exhibitors attended the conference providing attendees, senior enlisted leaders and Soldiers and Airmen an opportunity to see individual military gear, educational opportunities, and programs and products. The attendees took the ample time provided by the agenda to visit with the exhibitors.

AGAUS CONFERENCE RECAP



The annual Adjutant General's Association of the United States (AGAUS) summer meeting was held June 3-5, 2019 in Whitefish, Montana at the Whitefish Lodge near Glacier National Park. For those that may not be familiar with AGAUS, it is a private, non-profit organization whose membership is composed of the 54 Adjutants General representing each state, territory, and District of Columbia. The organization is a leading advocate to ensure the National Guard is organized, equipped, and postured to fulfill their responsibilities across the full spectrum of operations inherent in the National Military Strategy (NMS) and the constitutions of the United States

Attendees at the event included the 54 Adjutants General along with senior leaders from across the National Guard and the Department of Defense. Additionally, Montana Governor Bullock provided his welcome to the group on June 3. Other key attendees included General Lengyel, Chief National Guard Bureau; General Garrett, CG U.S. Army Forces Command; Lieutenant General (LTG) Laura Richardson, the new Commander, U.S. Army North; and Major General (MG) Whittington, Acting Director, Army National Guard directorate. Additionally, nearly 50 industry sponsors and representatives attended the event as well as many spouses and other guests of the Adjutants General.

The event schedule incorporated updates from several senior leaders to include General Lengyel, General Garrett, and General McConville, incoming Army Chief of Staff, and Lieutenant General Richardson. Each day, the Adjutants General met mostly in open sessions to discuss organizational priorities. The highlight of these sessions was the committee breakouts. Additionally, networking events were scheduled each day, affording industry attendees and National Guard leaders to forge new relationships and strengthen already existing relationships. With more than 30% turnover in Adjutants General this year, the networking events were incredibly beneficial for all attendees. The NGAUS Corporate Advisory Panel also held an open session attended by most Industry, as well as NGAUS, representatives.

On day three of the event, the group conducted a review of the 2019 AGAUS priorities. These included full-time manning, duty status reform, reserve component medical readiness, the National Guard Imperatives Campaign (including concurrent and proportional fielding of equipment) and meeting end strength goals. Emerging issues included military construction funding, National Guard equities in the DoD Cyber program, counterdrug funding, National Guard equities in the new Space Force, and the National Guard of the Future.

Finally, the group elected a new slate of officers for the next two years. These include MG Matt Quinn (Montana) as President, Maj Gen Mike Loh (Colorado) as Vice President – Air, MG Tim Williams (Virginia) as Vice President – Army, MG Joe Logan (Hawaii) as Treasurer, and MG Chris Callahan (Rhode Island) as Secretary.

The summer 2020 AGAUS meeting will be held in New Mexico.

The fee includes the workshop the afternoon of the 9th followed by a reception; a Continental breakfast, lunch, and an afternoon reception on the 10th, normally starting at 4:45PM. 2019 NGAUS TRIP TO NORMANDY AND PARIS, FRANCE



This past June, the 75th Anniversary of D-Day, June 6th, 1944, was memorialized throughout Western Europe and the United States. In 1944, the National Guard's 29th Infantry Division (MD, DC, VA) landed on Omaha Beach that morning and changed the course of World War Two. In 2019, the National Guard Educational Foundation sponsored a VIP trip to the NGAUS Monument in Vierville-sur-Mer, Normandy, France to commemorate the event. In attendance were Major General Donald P. Dunbar, NGAUS Chairman of the Board and the Adjutant General of Wisconsin, BG (Ret) Roy Robinson, the NGAUS President, MG (Ret) Max Haston, former TAG of Tennessee, BG (Ret) Steve Joyce, and CMSgt (Ret.) Dick Smith of USAA. The group took part in several ceremonies including a dawn arrival at Omaha Beach, the formal ceremonies at the American Cemetery in Coleville-sur-Mer, and ceremonies at the National Guard Memorial and the 29th Infantry Division Memorial. The entire group was grateful for the opportunity to memorialize the service of the soldiers who fought for the fate of the Free World that day.
