Dear Majority Leader Thune, Republican Whip Barrasso, Minority Leader Schumer, and Democratic Whip Durbin,

Our National Guard and Reserves are a vital asset to the Nation's defense both at home and abroad. The Guard and Reserves comprise nearly 40% of the Joint Force with over a million personnel and on their behalf, we urge you to pass appropriations to ensure we care for those who defend the Nation. The government shutdown hurts all government employees but the impact on the Guard and Reserve is uniquely painful. We respectfully request that Congress either pass a Continuing Resolution or a stand-alone bill to pay our Active Guard and Reserve (AGRs), Training and Administration of Reserve (TAR) members, technicians (both dual status and civilian), and our drilling Guard and Reserve members.

Since the start of the Government Shutdown on October 1, 2025, the Reserve Components' ability to continue to train and maintain military readiness has been severely hindered. Undue hardships have been placed on both service members and their families to include some providers denying TRICARE healthcare coverage for dependents during shutdown. Guard and Reserve members get 39 days a year to train so any disruption in training, schools, and maintenance present downstream negative impacts on warfighting readiness. As drill weekends are cancelled and critical personnel are furloughed, equipment and personnel readiness continue to degrade.

Therefore, on behalf of the members of our organizations, we urge Congress to end this shutdown by finding a compromise to fund the federal government through passage of the annual appropriation bills, a Continuing Resolution, or stand-alone legislation which will pay our AGR/TARs, technicians, and our Selected Reservists. It is crucial that we fund our National Guard and Reserves to ease their financial burden and maintain strategic readiness.

We appreciate your consideration of this critical issue for the Nation's Guard and Reserve.
