National Guard Adjutant General Award Nominated to Receive: The Patrick Henry Award

NGAUS Individual Award Nomination: Meg Louwagie, Staff Assistant, Office of Congressman Collin Peterson

Nominated by: Maj. Gen. Jon Jensen

Justification for Award: Meg Louwagie has served MN's 7th District as a member of Congressman Collin Peterson's staff for 17 years. Throughout that time, she has been a mainstay of the Congressman's Constituent Services and Outreach operations, helping the constituents of the 7th District communicate with their the representative and resolve their issues with federal agencies. A dedicated public servant seeking only to help others, Meg is extremely humble and getting her to share any one of her countless successes can be a Herculean task. Aside from serving as the Congressman's lead military and veterans' issues caseworker, she also facilitates the District 7's Congressional Art Competition and helps handle cases relating IRS, Social Security, passport, immigration, and employee compensation.

- Working on roughly 25-30 cases at a time, Meg Louwagie has closed several thousand cases over her tenure. She is the primary staff member for all military and veterans' casework for Congressman Peterson. Any constituent in the 7th District that has a military or veteran-related issue concerning a federal agency, including anything falling under the jurisdiction of the Departments of Defense or Veterans Affairs, can call on Meg to be their advocate and mediator, improving lines of communication.
- She has helped mediate issues between veterans and VA hospitals/clinics, recovered missing service records, and ensured veterans receive their duly earned benefits. Meg says that veterans' cases are often unique, wide ranging is the scope with no two alike. Recently, she dealt with resolving issues that have stemmed from glitches in the VA's computer system. Several veterans were unable to receive their GI Bill benefits due to this computer error, and Meg was able to help them get them restored. In another recent case, the VA had denied dental care necessitated by a car accident because of missing medical records, and Meg helped the veteran locate those records so he could receive the much needed care.
- She assists Veteran Service Officers with research and information requests. Meg has
 helped research and present several service medals, helping veterans and their families
 ensure that they receive all of the recognition they are eligible for.
- Outside of casework, Meg also relays legislative/policy proposals and ideas that she hears from constituents and organizations to legislative staffers in DC.
- Service Academies: Over the past 4 years especially, Meg has taken on the lead role in the
 Congressman's Service Academy responsibilities. She organizes Service Academy nights to
 provide information to interested students. In hope of expanding the service academy
 program, she is organizing additional informational nights this year and partnering with
 surrounding congressional offices to pull in more students. Finalists are interviewed by a
 panel of service academy graduates, who make recommendations to the Congressman.
 Outside this process, she also works with students and academy liaison officers to help
 students through the process. This past year, Congressman Peterson made 3 nominations
 to the Service Academies through Meg's management, and all three were appointed —
 including two best friends from Willmar.

• Townhalls & Events: Just since February, Meg has organized 6+ town halls on military and veterans issues all across the district (e.g. Alexandria, Marshall, Hutchinson, Willmar), with more likely to happen throughout the year. She works closely with the National Guard, the VA, and Veterans groups, regularly attending events they put on to include: providing legislative updates at the monthly Twin Cities United Veterans Legislative Council meetings, making regular trips to all area VA Health Care Systems (Fargo, Minneapolis, Sioux Falls, St. Cloud), visits with County Veteran Service Officers (CVSOs), and Quarterly National Guard Breakfast Briefings to receive updates from the Minnesota National Guard.
