The following are important items HRO's / CSR's should be aware of:

- CSR's must work closely with ING ReliaStar to ensure premium payroll deductions are correct. **If premium deductions are not kept current, the Technician's coverage may lapse.**
- CSR's will be notified when to begin **new** deductions as follows. TechLife and TechPay- HRO sends Open Enrollment form to CSR for their records. ReliaStar will follow up with the CSR to confirm approval of enrollment/application and to give deduction start dates and amounts.
- Premium Changes due to an age change:** Age changes will be automatically calculated by ReliaStar at the beginning of each year and the following Monthly Summary of Changes report will include the changes in premiums due to age changes. CSRs will enter the deduction changes into the Defense Civilian Pay System (DCPS), NGAUS INSURANCE screen.
- Premium Changes due to salary change:** Salary Change Reports which list what ReliaStar has for salary information will be sent out by ReliaStar once per year (usually November). HRO's / CSRs are responsible for reviewing these reports and returning the reports to ReliaStar with updated salary information. ReliaStar will then calculate correct premiums and notify CSR's (via Monthly Summary of Changes reports). CSR enters the appropriate deduction changes into DCPS.
- ReliaStar performs full reconciliations on technician premiums periodically. The DFAS NGAUS Interface Files are compared against ReliaStar records. Reports listing discrepancies are sent to the input sites. CSRs are responsible for reviewing reports and entering changes into the DCPS system.
